What is this product?

Type

BEL CANTO BOHEME FLEXIBLE ALLOCATION (the "Sub-Fund") is sub-fund of BEL CANTO SICAV, a UCITS incorporated in Luxembourg.

Term

The Sub-Fund is established for an unlimited period. The Sub-Fund may not be unilaterally terminated by Santander Asset Management Luxembourg. The Sub-Fund can be dissolved early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

Objective: The investment objective of the Sub-Fund is to build a diversified portfolio of securities issued by companies or by governments or their local authorities established, listed or traded worldwide, including investments in OECD and emerging countries. The Sub-Fund will invest directly, or indirectly through investment funds and ETFs, in fixed income securities and equity securities (including closed-ended REITS) while seeking to control economic and monetary risk. Asset allocation will vary based on the Investment Manager's macroeconomic views and business cycle outlook.

Investment policy: The Sub-Fund will primarily seek to achieve its investment objective by investing its net assets in third party UCITS and UCIs (including ETFs) which may represent up to 100% of the Sub-Fund's net assets.

The Sub-Fund's investments in equities will be 50% of the Sub-Fund's net assets. The Sub-Fund's exposure to equities will not exceed 90% of the Sub-Fund's net assets. The maximum exposure to fixed income instruments will be 97% with a minimum of 10% of the Sub-Fund's net assets.

The Sub-Fund can invest up to 50% of its net assets in non-investment grade fixed income instruments. Investments in emerging markets will be limited to 50%.

The Sub-Fund may invest up to 50% of its net assets in alternative investments. The Sub-Fund may invest up to 30% of its net assets in exchange-traded commodities (ETCs). The sub-fund could indirectly

invest in ABS, MBS and contingent convertible bonds up to 20% of its net assets. The Sub-Fund will not invest more than 20% of its net assets in cash and deposits for liquidity purposes. The Sub-Fund might be invested in money market instruments for up to 100% of its net assets. The Sub-Fund's portfolio may be exposed to non-USD currencies with no restrictions.

The Sub-Fund may also invest in financial derivative instruments such as options, futures and forwards to achieve the exposure to the asset classes as well as for hedging purposes.

The Sub-Fund is actively managed in reference to a composite index: 50% MSCI ACWI Index, 30% ICE BofA US Broad Market Index, 10% Bloomberg Commodity Index, 10% Secured Overnight Financing Rate 90D. The Sub-Fund does not neither track the Benchmark nor uses it for portfolio allocation purposes.

Net asset value calculation frequency: Daily, any Luxembourg Business day.

This is an accumulation share class in PLN.

The Sub-Fund's reference currency is USD. This share class is denominated in PLN. Currency hedging may be used to reduce risk exposure associated with USD/PLN exchange rate fluctuations.

Intended retail investor:

This Sub-Fund may not be appropriate for investors who plan to withdraw the money within 3 years.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Sub-Fund as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the Sub-Fund's capacity to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you may get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Besides the market risks included in the risk indicator, other risks may affect the share performance:

Operational, Sustainability, Currency, Derivatives, Market, Emerging Markets risks. Please refer to the Prospectus for full details about the risks associated with this Sub-Fund.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What happens if Santander Asset Management Luxembourg is unable to pay out?

The investor may not face a financial loss due to the default of Santander Asset Management Luxembourg S.A. (the PRIIP Manufacturer). Investors may suffer a financial loss in the event of the insolvency of the depositary, or someone acting on its behalf, which will not be covered by any investor compensation or guarantee scheme. However, this risk is mitigated by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- PLN 50 000 per year is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 3 year/s. Subscription, conversion and repurchase applications must be notified before 1 p.m. (Luxembourg time) on the Business Day preceding the Valuation Date on which the application is to be effected. Applications notified after this deadline shall be dealt with on the following Valuation Date.
