## What is this product?

### Type

SANTANDER AM EURO CORPORATE BOND (the "Sub-Fund") is a sub-fund of a SICAV, SANTANDER SICAV, a UCITs incorporated in Luxembourg.

### Term

The Sub-Fund is established for an unlimited period. The Sub-Fund may not be unilaterally terminated by Santander Asset Management Luxembourg. The Sub-Fund can be dissolved early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

**Objective:** The Sub-Fund is actively managed and aims to outperform the ICE Bank of America /Merrill Lynch Euro Corporate Index (the "Benchmark"). The investment manager uses the Benchmark as a reference to build the portfolio. The majority of the Sub-Fund's holdings are included in the Benchmark. Nevertheless, investments outside the Benchmark universe are permitted in order to take advantage of specific opportunities. Although the deviation from the Benchmark could be relatively low in terms of tracking error if the fund is neutral in terms of duration, the investment manager will take views on various issuers, sectors, countries, ratings and duration, that differ from the Benchmark positioning. These views are based on both a top down / bottom up approach based on fundamental and technical analysis of each component.

**Investment policy:** This Sub-fund will invest mainly in a diversified portfolio of euro corporate bonds, including both investment grade and

non-investment grade securities. The assets invested in non-investment grade securities (with a rating by major rating agencies or market benchmarks) may not exceed 25% of the net asset value of the Sub-fund. In order to provide risk control, this Sub-Fund may also use derivatives. The Sub-fund may use derivatives with a view to reduce the risk of investment positions or for efficient portfolio management or as a part of the investment strategy.

**SFDR Classification:** The Sub-Fund promotes environmental and/or social characteristics within the meaning of article 8 of the Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector ("SFDR").

**Net asset value calculation frequency:** Daily, any full Business day.

This is an accumulation share class in EUR.

### Intended retail investor:

This Sub-Fund may not be appropriate for investors who plan to withdraw the money within 2 years.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Sub-Fund as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the Fund's capacity to pay you.

**Be aware of currency risk.** You may receive payments in a different currency, so the final return you may get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Beside the market risks included in the risk indicator, other risks may affect the share performance:

Credit, Liquidity, Counterparty, Operational, Sustainability, Currency, Derivatives, Market, Interest Rate risks. Please refer to the Prospectus for full details about the risks associated.

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10,000 per year is invested.

## How long should I hold it and can I take money out early?

### **Recommended holding period: 2 years**

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 2 years. Subscription, conversion and redemption applications lodged with the Registrar and Transfer Agent in Luxembourg on any Dealing Day (whereas a “Dealing Day” is any full Business Day preceding a Valuation Day) before 16:00 Luxembourg time (the “cut off time”), will be processed on that Dealing Day, using the net asset value per Share determined on the next Valuation Day for the relevant Class.
