What is this product?

Type

SANTANDER CORPORATE COUPON (the "Sub-Fund") is a sub-fund of a SICAV, SANTANDER SICAV, a UCITs incorporated in Luxembourg.

Term

The Sub-Fund is established for an unlimited period. The Sub-Fund may not be unilaterally terminated by Santander Asset Management Luxembourg. The Sub-Fund can be dissolved early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

Objective: The objective of the Sub-Fund is to achieve a high level of current income.

Investment policy: To achieve this objective, this Sub-Fund will invest mainly in a diversified portfolio of international corporate bonds, including both investment grade and non-investment grade securities. This Sub-Fund may additionally invest in public fixed income securities, money market and cash instruments. This Sub-Fund may also invest up to 10% of its net assets in fixed income securities issued by companies located or carrying their main activity in emerging markets.

The assets invested in below investment grade securities (investments rated below BBB- or Baa3 by major rating agencies or market benchmarks at the time of the investment) may not exceed 50% of the net asset value of the sub fund. No more than 10% of this Sub-Fund's portfolio will be rated below B- by major rating agencies or market benchmarks.

The fixed income securities in which the Sub-Fund invests will be listed principally in stock exchanges of EU Member States and USA, and to a minor extent, in stock exchanges of other OECD countries.

This Sub-Fund may use techniques and instruments for hedging purposes.

This Sub-Fund may combine direct investment in securities or investment through financial derivative instruments. These derivatives may enter into

with highly rated financial institutions specialising in this type of transactions and participating actively in the relevant market.

The Sub-Fund may use derivatives with a view to reduce the risk of investment positions or for efficient portfolio management or as a part of the investment strategy.

The Sub-Fund is actively managed in reference to the ICE BofA 1-5 Year US Corporate Excluding 144a Index (the "Benchmark"). The Sub-Fund does not track the Benchmark. The reason for referring to the Benchmark in this investment policy is to indicate that it is used for performance comparison purposes. However, the Investment Manager uses its discretion to select holdings based on an analysis of market conditions and an analysis of a company's prospects and valuations. As such, the Investment Manager will not hold all of the Benchmark constituents.

SFDR Classification: The Sub-Fund promotes environmental and/or social characteristics within the meaning of article 8 of the Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector ("SFDR").

Net asset value calculation frequency: Daily, any full Business day.

This is a USD distribution share class. Unless specifically decided by the Board of Directors, the dividends will be paid to shareholders.

Intended retail investor:

This Sub-Fund may not be appropriate for investors who plan to withdraw the money within 2 years.

What are the risks and what could I get in return?

Risk Indicator



 The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Sub-Fund as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the Fund's capacity to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you may get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Beside the market risks included in the risk indicator, other risks may affect the share performance:

Credit, Liquidity, Sustainability, Currency, Derivatives, Market, Interest Rate, Emerging Markets risks. Please refer to the Prospectus for full details about the risks associated with this fund.

Performance Scenarios

What happens if Santander Asset Management Luxembourg is unable to pay out?

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- USD 10,000 per year is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 2 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 2 years. Subscription, conversion and redemption applications lodged with the Registrar and Transfer Agent in Luxembourg on any Dealing Day (whereas a “Dealing Day” is any full Business Day preceding a Valuation Day) before 16:00 Luxembourg time (the “cut off time”), will be processed on that Dealing Day, using the net asset value per Share determined on the next Valuation Day for the relevant Class.
